The said transmission or distribution lines covered by this grant shall be buried at such a
depth as not to interfere with the ordinary cultivation of said lands and upon grantor's
request, the grantee shall provide the grantor with a plat showing the location of said
buried cables and the grantor agrees that no building, structures, or other obstructions
shall be places directly above said power, transmission or distribution lines.
