

The North Half (N½) of Lot One (1) and the East one (1) foot of the North Half (N½) of Lot Two (2) in Block Ten (10) of Pitzer & Knight's Addition to the Town of Winterset, Madison County, Iowa;

## **AND**

of said Lot Four (4); thence N89°50'27" W 41.50 feet along the South line of said Lot Four (4) and the extension thereof to a point on the West line of a 16.5 foot alley running northerly and southerly through said Block Two (2); thence S0°09'27" W 92.28 feet along said West line; thence N33°25'51" W 154.54 feet; thence northerly 90.97 feet along a 229.59 foot radius curve concave easterly and having a chord bearing N22°04'47" W 90.38 feet to a point on the North line of Lot Two (2) of said Block Two (2); thence S89°50'27" E 136.20 feet along the North line of said Lot Two (2) and the extension thereof to the Point of Beginning, excepting therefrom present established alley, said parcel contains 17,359 square feet;

### AND

A parcel of land located in Lots One (1) Two (2), Three (3), Four (4), Five (5), Six (6), Seven (7), and Eight (8) in Block One (1) of Hornback and Bevington Addition to the City of Winterset, Madison County, Iowa, said parcel being more particularly described as follows: Beginning at the SW corner of Lot Five (5) of said Block Two (2); thence N0°09'27" E 247.28 feet along the West line of said Block Two (2); thence N89°49'05" E 230.25 feet; thence S33°25'51" E 59.18 feet to a point on the East line of said Block Two (2); thence S0°09'27" W 198.50 feet along said East line to the SE Corner of Lot Four (4) of said Block Two (2); thence S89°58'32" W 262.99 feet along the South line of said Block Two (2) to the Point of Beginning, excepting there from present established alley, said parcel contains 60.229 square feet;

### **AND**

The West One-third (1/3) of Lot Six (6) in Block Eleven (11) of the Original Town of Winterset, Madison County, Iowa.

This deed is exempt from the Iowa Transfer Tax pursuant to Iowa Code Section 428A.2(15). Therefore, no Declaration of Value or Ground Water Statement is required.
