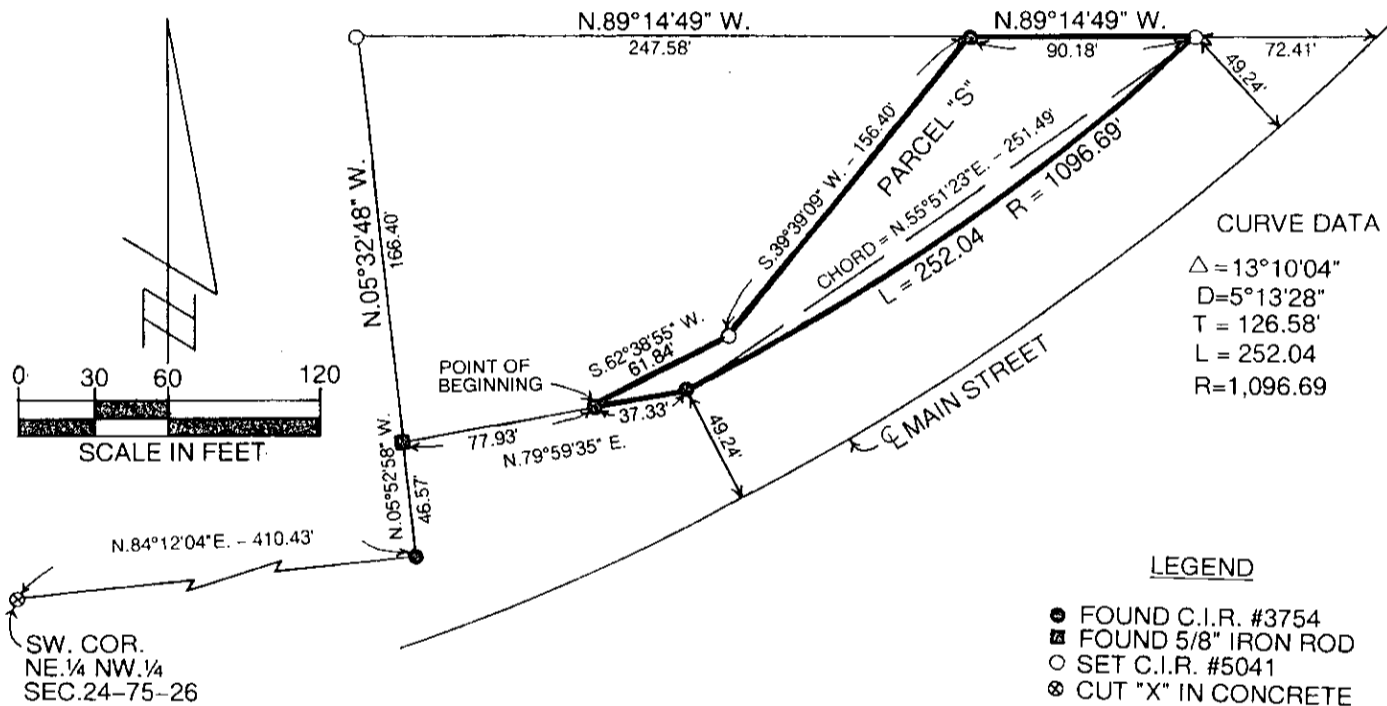

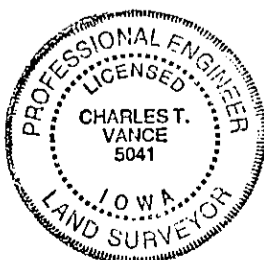


LEGAL DESCRIPTION:

Parcel "S" in the Northeast Quarter of the Northwest Quarter of Section 24, Township 75 North, Range 26 West of the 5th P.M., City of St. Charles, Madison County, Iowa more particularly described as follows:

Commencing at the Southwest Corner of the Northeast Quarter of the Northwest Quarter of Section 24, Township 75 North, Range 26 West of the 5th P.M., Madison County, Iowa; thence North 84°12'04" East, 410.43 feet; thence North 05°52'58" West, 46.57 feet; thence North 79°59'35" East, 77.93 feet to the point of beginning. Thence continuing North 79°59'35" East, 37.33 feet; thence Northeasterly 252.04 feet along a 1,096.69 foot radius non-tangent curve concave Northwesterly with a central angle of 13°10'04" and a long chord bearing North 55°51'23" East, 251.49 feet; thence North 89°14'49" West, 90.18 feet; thence South 39°39'09" West, 156.40 feet; thence South 62°38'55" West, 61.84 feet to the point of beginning and containing 0.1848 Acres.
