FIRST AMENDMENT
TO
AGREEMENT AND CONTRACT FOR FIRE PROTECTION AND EMERGENCY
RESPONSE SERVICE BETWEEN THE CITY OF LORIMOR, IOWA AND JONES
TOWNSHIP, UNION COUNTY, IOWA, NEW HOPE TOWNSHIP, UNION COUNTY,
IOWA, MONROE TOWNSHIP, MADISON COUNTY, IOWA, AND WALNUT
TOWNSHIP, MADISON COUNTY, IOWA

Whereas, the City of Lorimor, Iowa (hereafter Lorimor) and Jones Township (hereafter Jones) in Union County, Iowa and New Hope (hereafter New Hope) in Union County, Iowa and Monroe Township (hereafter Monroe) in Madison County, Iowa and Walnut Township (hereafter Walnut) in Madison County, Iowa have made and entered into a Iowa Code Chapter 28E Agreement, dated February 1, 2002;

Whereas, that Agreement provides for its amendment upon the unanimous approval of the aforementioned political subdivisions of the State of Iowa;

Whereas, the City of Thayer, Iowa (hereafter Thayer) desires to become a party to this Agreement and subject to the rights and duties under the Agreement;

Whereas, the aforementioned signatories to this Agreement by their signature to this First Amendment acknowledge that their respective governing body has previously approved this First Amendment in all respects; and,

Whereas, the parties authorize and approve this First Amendment upon being signed by all parties hereto to be filed with the proper government offices as provided by Iowa Code Chapter 28E.

NOW, THEREFORE, IT IS AGREED BY THE UNDERSIGNED PARTIES AS FOLLOWS:

1. The above referenced Agreement be and is hereby amended to add the City of Thayer, Iowa as a party to this Agreement subject to all rights and duties as therein provided.
2. Thayer agrees as part of this Agreement to pay as their cost share under Paragraph 7 of the Agreement a sum of money annually to Lorimor equal to Sixty and Three-fourths (60.75) Cents per Thousand Dollars of Taxable Valuation of the assessable property within Thayer.
3. The undersigned parties agree under Paragraph 8 of the Agreement be and is hereby amended to provide that the membership of the Fire Advisory Board shall be increased to allow Thayer to have one (1) elected official serve on that Board with the same rights and duties as the other Board members.
4. The undersigned parties ratify and confirm the aforementioned Agreement in all respects, except as expressly amended herein.

5. The undersigned parties agree this First Amendment to the Agreement shall be in full force and effect from and after fifteen (15) days from the date of the last date of approval by the undersigned governing bodies.
