

Addendum

1. A tract of land described as follows, to-wit: Commencing as a point of reference at the Southwest corner of Section Fifteen (15), in Township Seventy-five (75) North, Range Twenty-nine (29) West of the 5th P.M., Madison County, Iowa, thence North 90°00' East 958.3 feet along the South line of the Southwest Quarter (1/4) of the Southwest Quarter (1/4) of said Section Fifteen (15) to the point of beginning (this is an assumed bearing for purposes of this description only), thence continuing North 90°00' East 361.5 feet along said South line of the Southwest Quarter (1/4) of the Southwest Quarter (1/4) of Section Fifteen (15) to the Southeast corner of said Southwest Quarter (1/4) of the Southwest Quarter (1/4) of Section Fifteen (15), thence North 90°06' East 394.5 feet along the East line of said Southwest Quarter (1/4) of the Southwest Quarter (1/4) of Section Fifteen (15), thence North 90°00' West 361.5 feet, thence South 00°06' West 394.5 feet to the point of beginning, and subject to encumbrances of record, and containing 3.3 Acres more or less including 0.3 Acres of Road Right of Way
