- 2. Mid-State Surveying & Consulting, Inc. and I, as an employee of Mid-State Surveying & Consulting, Inc., were retained by Judy A. Burdess to complete all surveying and related work necessary to prepare a Final Plat of the contemplated Burdess Subdivision to the City of Patterson, Madison County, Iowa, and I have done so using information that I would use and rely upon in my capacity as a licensed surveyor under the laws of the State of Iowa.
