

A parcel of land located in the Northeast Quarter (1/4) of the Southwest Quarter (1/4) and the Northwest Quarter (1/4) of the Southwest Quarter (1/4) of Section Twenty-nine (29), Township Seventy-six (76) North, Range Twenty-six (26) West of the 5th P.M., in the City of Patterson, Madison County, Iowa, more particularly described as follows, to-wit: Beginning at a 5/8" iron pin on the North line of North Street and on the West line of the Northeast Quarter (1/4) of the Southwest Quarter (1/4) of said Section Twenty-nine (29), thence North 00°14'15" East along the West line of the Northeast Quarter (1/4) of the Southwest Quarter (1/4) of said Section Twenty-nine (29) a distance of 157.72 feet to a 1/2" iron pin, thence South 83°38'00" West a distance of 181.50 feet to a 1/2" iron pin, thence North 00°14'15" East a distance of 247.50 feet to a point, thence North 83°38'00" East a distance of 181.50 feet to a ½" iron pin on the West line of the Northeast Quarter (1/4) of the Southwest Quarter (1/4) of said Section Twenty-nine (29), thence South 00°14'15" West along the West line of the Northeast Quarter (1/4) of the Southwest Quarter (1/4) of said Section Twenty-nine (29) a distance of 4.31 feet to a 1/2" iron pin, thence North 85°15'33" East a distance of 294.03 feet to a "iron pin on the Northeast corner of Parcel "B" of said Section Twenty-nine (29), thence South 08°39'58" East along the East line of said Parcel "B" a distance of 190.41 feet to a 1/2" iron pin on the Southeast corner of said Parcel "B", thence South 08°39'58" East a distance of 41.37 feet to a 1/2" iron pin, thence South 00°14'15" West a distance of 161.25 feet to a cotton gin spike on the North line of North Street, thence South 83°56'36" West along the North line of North Street a distance of 330.79 feet to the point of beginning, containing 3.93 acres,
