

The undersigned, on oath, states as follows:

- 1. My name is Sarah B. Tinney and I am a licensed attorney with the State of Illinois and have been so since 1977.
- 2. I was one of the attorneys representing the Petitioner in *Ehrhardt v. Ehrhardt*, Champaign County Case No.: 97-D-718.
- 3. That on May 5, 2006 a Memorandum Opinion, Judgment of Dissolution of Marriage and Judgment as to Auler Attorney's Fees was entered and signed by the Honorable Judge Arnold Blockman, a dually sworn and elected judge of Champaign County, Illinois, which states in part as follows:

ORDER ON PETITION FOR AID AND DIRECTION

THIS CAUSE COMING ON FOR HEARING this 7th day of July, 2006, on the Petitioner's Petition for Aid and Direction, the Petitioner being personally present and by her counsel, Sarah B. Tinney of Erwin, Martinkus & Cole, Ltd. and the Respondent being present by his attorney, Steve Thomas, and the Court having heard the arguments of the parties, THE COURT ORDERS AS FOLLOWS:

- A. That Dan Walsh, Sheriff of Champaign County, is to execute the following documents:
