## Addendum

A tract of land described as follows, to-wit: Commencing at the Northwest corner of the Southeast Quarter (1/4) of the Southwest Quarter (1/4) of Section Sixteen (16), in Township Seventy-five (75) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, and running-thence East 10 chains to the public road, thence in a Southeasterly direction along said road to a point 20 rods West of the Southeast corner of said 40-acre tract, thence West along the South line of said Section five (5) chains to Middle River, thence North and West following the meanderings of said River to a point 3.25 chains South of the point of beginning, thence North to the point of beginning, containing 16 acres more or less, EXCEPT a parcel of land located in the Southeast Quarter (1/4) of the Southwest Quarter (1/4) of said Section Sixteen (16), described as commencing at the Northwest Corner of the Southeast Quarter (1/4) of the Southwest Quarter (1/4) of said Section Sixteen (16); thence N. 90°00'E. 340.00 feet along North line of said Southeast Ouarter (1/4) of the Southwest Quarter (1/4) to Point of Beginning; thence S. 23°52'E. 1,269.3 feet; thence N. 90000'E. 130.0 feet to the centerline of a county road; thence N. 15°35'W. 1,205.0 feet along centerline of county road to the North line of said Southeast Quarter (1/4) of the Southwest Quarter (1/4); thence N. 90°00'W. 320.0 feet along North line of said Southeast Quarter (1/4) of the Southwest Quarter (1/4) to Point of Beginning containing 5.995 Acres including 0.553 Acres of county road right of way. (Note: The North line of the Southeast Quarter (1/4) of the Southwest Quarter (1/4) of Section Sixteen (16), Township Seventy-five (75) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa is assumed to bear due East and West,)

Grantors also convey a perpetual easement for ingress and egress and for utility purposes over, under and across the following described real estate: Commencing at the Southeast corner of Tract Two (2) described above, thence West 400.0 feet along the South line of the Northeast Quarter (1/4) of the Southwest Quarter (1/4) of said Section Sixteen (16); thence North 36.0 feet; thence East to the center of the County Road; thence Southeasterly along the center of the County Road to the point of beginning.
