That part of a county road easement platted October 20, 1932, recorded in Easement Book 70, Page 222, on file in the Madison County Recorders Office, Madison County, located in Section 36, Township 76 North, Range 26 West of the Fifth Principal Meridian, Madison County, Iowa, said county road described as follows:

Commencing at the Southwest Corner of Section 36 T76N R26W thence East 1111.2 ft; thence North 2065.1 ft. to the point of beginning; No. 1:- thence N 13°35' E 150.8 ft; thence S 47°24' W 135.1 ft; thence S 70°34' W 100.0 ft; thence S 83° 14' W 100.0 ft; thence N 67° 42' W 72.0 ft; thence S 60°14' W 50.7 ft; thence S 67°45' E 113.7 ft; thence N 83°19' E 264.9 ft. to the point of beginning, containing 0.47 Acres, more or less.
