

An undivided one-eighth (1/8) interest in and to:

Northwest Fractional Quarter (NW Fr 1/4) of Section Four (4), Township 77 North, Range 27 West of the 5th P.M., Madison County, Iowa, EXCEPT Parcel "A" of the Survey of the Southwest Quarter of the Northwest Quarter (1/4) of Section Four (4), Township Seventy-Seven (77) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa, as shown in Plat of Survey filed in Book 3, Page 515 in the Office of the Madison County Recorder, Also described as follows: Beginning at the Southeast Corner of the Northwest Quarter of Section Four (4), Township Seventy-seven (77) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa; thence North 90°00'00" West along the South line of the Northwest Quarter of said Section Four (4), a distance of 200.00 feet; thence North 00°38'24" West parallel to the East line of the Northwest Quarter of said Section Four (4), a distance of 233.00 feet; thence South 90°00'00" East parallel to the South Line of the Northwest Quarter of said Section Four (4), a distance of 200.00 feet to a point on the East line of the Northwest Quarter of said Section Four (4); thence South 00°38'24" East along the East line of the Northwest Quarter of said Section Four (4), a distance of 233.00 feet to the Point of Beginning, Containing 1.07 acres including 0.15 acres of Road Right of Way, AND EXCEPT A tract of land in the Northwest Fractional Quarter (NW Fr 1/4) of the Northwest Quarter (1/4) of Section Four (4), Township Seventy-seven (77) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa, more particularly described as follows: Beginning at the Northwest Corner of Section Four (4), Township Seventy-seven (77) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa; thence South 00°00'00" 937.44 feet along the West line of the Northwest Quarter (1/4) of said Section Four (4); thence North 88°17'17" East 256.96 feet; thence North 00°53'02" West 331.88 feet; thence South 88°50'40" West 50.81 feet; thence North 00°00'27" East 597.44 feet to the North line of the Northwest Quarter (1/4) of said Section Four (4); thence North 89°34'15" West 201.01 feet to the point of beginning.
