I, Mark Nitchals, being first duly sworn on oath, state that I am the City Administrator for the City of Winterset, Madison County, Iowa. I further state that this Affidavit concerns the chain of title to the following described real estate:

AN ORDINANCE VACATING ALLEY LOCATED IN BLOCK FIVE (5) OF THE WEST ADDITION TO THE CITY OF WINTERSET IOWA.

BE IT ORDAINED by the City Council of the City of Winterset, Iowa:

SECTION 1. The following described alley located in Block five (5) of the West Addition to the City of Winterset, Iowa is hereby vacated as a public right of way: Commencing at the Northwest Corner of Lot Ten (10) of Block Five (5) in the West Addition to the Town of Winterset, Madison County, Iowa, thence South 198 feet to the Southwest Corner of Lot Eight (8) of said block, thence West 16½ feet to the Southeast Corner of Lot Seven (7) of said block, thence North 198 feet to the Northeast Corner of Lot Five (5) of said block, thence East to the point of beginning.

SECTION 11. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 111. This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

WHEREAS, the Cityof Winterset, Iowa, has passed and adopted an Ordinance No 280 vacating the North-South Alley located in Block five (5) of the West Addition to the City of Winterset, Iowa, and

WHEREAS, the Council now proposes to sell said vacated alley which is legally described as:

Commencing at the Northwest Corner of Lot Ten (10) of Block Five (5) in the West Addition to the Town of Winterset, Madison County, Iowa, thence South 198 feet to the Southwest Corner of Lot Eight (8) of said Block, thence West 16½ feet to the Southeast Corner of Lot Seven (7) of said block, thence North 198 feet to the Northeast Corner of Lot Five (5) of said block, thence East to the point of beginning,
