EASEMENT

Robert M. Casper and Margaret M. Casper, husband and wife, and John E. Casper and Lynee' D. Casper, husband and wife, hereinafter called "Grantors, in consideration of One Dollar (\$1.00) and other valuable consideration, do hereby grant to Zuendel Investments, Inc., hereinafter called "Grantee", and to its successors or assigns, the perpetual right and easement over, under and across the following described real estate in Madison County, Iowa, to-wit:

The West Half (1/2) of the Northwest Quarter (1/4) of Section Twenty (20), Township Seventy-six (76) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa

together with the right of ingress and egress over and across said easement area for the purpose of constructing, installing, laying, and thereafter using, operating, inspecting, repairing, maintaining, and replacing sanitary sewer over, across and through said real estate.

The easement shall be 30 feet in width lying South and West and adjacent to the existing private road to the Gun Club running across said real estate. The private road runs from the county road on the East side of the real estate described above and runs Northwest to said Gun Club.

Grantors shall have no responsibility or liability for any claim, cause of action, or demand for any damage to said sanitary sewer from any cause, including acts of Grantors.
