Notice is hereby given that an Indictment was returned by a federal grand jury and filed by the United States of America in the United States District Court for the Southern District of Iowa on the 19<sup>th</sup> day of December 2006, and is now pending in this Court, involving the potential forfeiture of real property described as follows:

All right, title and interest in the subject real property vested in the United States upon commission of the acts giving rise to forfeiture under 18 Untied States Code § 982(b)(1) incorporating 21 United States Code.
