## ASSUMPTION AGREEMENT

The real property described in the mortgage, except a portion thereof, upon which Partial Releases have been granted shall remain subject to the lien, charge or encumbrance of the mortgage and nothing contained in this Agreement or done pursuant to it shall affect or be construed to affect the lien, charge or encumbrance of the mortgage or the priority of the mortgage over other liens, charges or encumbrances.
- Turners shall remain personally liable upon said Note and Mortgage. This Assumption
  Agreement is not a release of Turners from personal liability upon said Note and
  Mortgage.
