I, Anna Katherine Livingston, being first duly sworn on oath, depose and state as follows:

- 1. I am the wife of Jack Livingston, who died on the 11th day of February, 2007, and have an interest in the real estate described below by virtue of Warranty Deed dated March 27, 2003, and filed April 1, 2003, in Book 2003, Page 1850 of the Recorder's Office of Madison County, Iowa.
- 2. There will be no estate proceedings instituted on account of the decedent's death.
