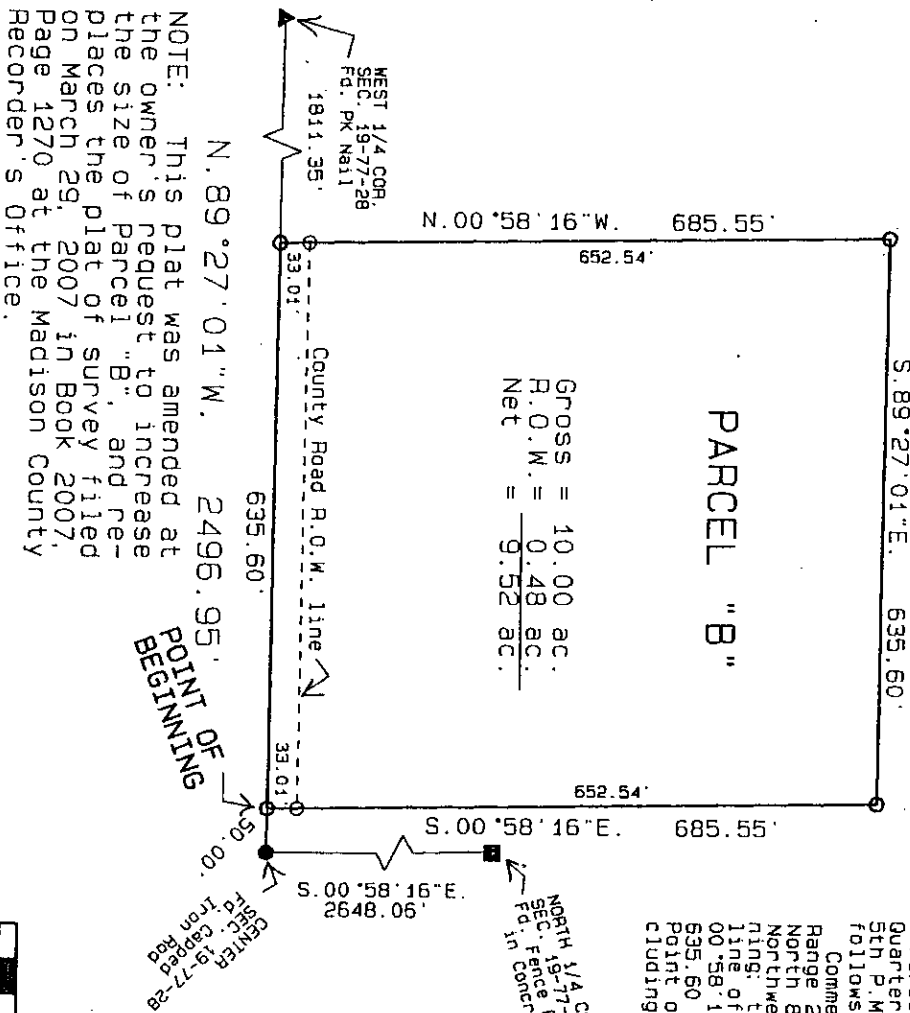

Commencing at the Center of Section 19, Township 77 North, Range 28 West of the 5th P.M., Madison County, Iowa; thence North 89° 27' 01\" West, 50.00 feet along the South line of the Northwest Quarter of said Section 19, to the Point of Beginning; thence North 89° 27' 01\" West, 635.60 feet along the South line of the Northwest Quarter of said Section 19; thence North 00° 58' 16\" West, 685.55 feet; thence South 89° 27' 01\" East, 635.60 feet; thence South 00° 58' 16\" East, 685.55 feet to the Point of Beginning. Said Parcel contains 10.00 acres, including 0.48 acres of County Road right-of-way.
