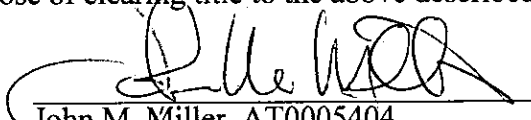
I further state and attest that the time for filing objections to exemptions has passed and no such objections have been filed.

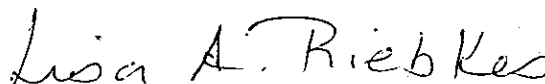
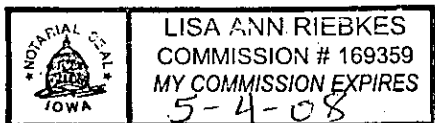
