EASEMENT

The Southwest Quarter (1/4) of the Southwest Quarter (1/4) of Section One (1), except the North 33 feet thereof, and except the right of way conveyed to the Chicago, St.Paul and Kansas City Railway Company in Township Seventy-five (75) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa, except that part of the above described real estate heretofore conveyed to the State of Iowa for highway purposes. The grant and other provisions of this easement shall constitute a covenant running with the land for the benefit of the GRANTEE, its successors and assigns.
