I, Lois Thompson, being first duly sworn on oath, depose and state as follows:

- 1. I am the wife of Art C. Thompson, who died on the 30th day of June, 2007, and have an interest in the real estate described below by virtue of the fact that I am a beneficiary of the Art Thompson Estate.
- 2. There will be no estate proceedings instituted on account of the decedent's death.
- 3. Pursuant to Section 450.22, subsection 3 of the lowa Code, no inheritance tax return is required to be filed in the Estate of Art C. Thompson since (i) there is no federal estate tax filing obligation, and (ii) all of the decedent's assets either were held in joint tenancy with right of survivorship solely between the decedent and individuals listed in Section 450.9 of the lowa Code as individuals that are entirely exempt from Iowa inheritance tax, or passed by beneficiary designation or pursuant to a trust intended to pass the decedent's property at death or through any other nonprobate transfer solely to individuals listed in Section 450.9 as individuals that are entirely exempt from Iowa inheritance tax.
- 4. The following described real estate was owned by the Art C. Thompson and Lois Thompson as Joint Tenants with Full Rights of Survivorship and Not as Tenants in Common, at the time of Art Thompson's death:
