All that part of the Southwest Quarter (1/4) Southeast Quarter (1/4) Section Twentyseven (27), Township Seventy-seven (77) North, Range Twenty-eight (28) West, Madison County, Iowa, described as a strip of land One-hundred Fifty (150) feet wide, being Seventy-five (75) feet on each side of the located main track centerline of the Chicago, Rock Island and Pacific Railroad Company's Earlham to Winterset line as now staked and located on, over and across said above described land, said main track center line being more particularly described as beginning at a point in the North line of said Quarter Quarter Two-thousand, three-hundred, Twenty-two and Two-tenths (2,322.2) feet East of the Southwest corner of the Northeast Quarter of the Southwest Quarter of said Section; thence Southerly in a straight line One-thousand, Three-hundred, Eighteen and Fourtenths (1,318.4) feet to a point in the South line of said Quarter Quarter Three-hundred (300) feet West of the Southeast Corner of the Southwest Quarter (1/4) Southeast Quarter (1/4) of said Section.
