Amendment II

Article IV Section 10 of the Declaration of Covenants, of the Conditions and Restrictions St. Johns Woods Madison County County, Iowa shall be amended to read as follows:

Section 10 Utilities. Each Owner shall be responsible for payment of all-utility*services*to-his-lot,*including*but-not-limited*to*electricity; water, gas, telephone, sewer services, and cable television services. Each owner or group of owners, shall also be responsible for servicing their private mechanical sanitary sewer systems or any other type of sewer system used, per manufacturers or designers recommendations, but in no case is less than annually, as well as maintaining same as to be in compliance with all health, safety, and other local county, state and federal codes, rules regulations or laws of each and every kind or nature applicable thereto.
