Olson</u> executed to the said <u>UNION STATE</u> BANK a mortgage bearing even date with the said note, upon real estate described in said mortgage as security for payment of said note, which mortgage was recorded in the office of the Recorder of Madison on the <u>26th</u> day of <u>July</u>, A.D., 1995, at <u>2:30</u> o'clock <u>P.</u> M., in Book <u>177</u> of Mortgages, on page 492 and, Whereas, \_\_James C. And Pamela A. Olson \_\_\_\_ is now the owner of the real estate described in said Whereas, there remains unpaid on the principal of said mortgage the sum of Sixty-four Thousand Six Hundred Thirty-nine and 01/100-----(\$ 64,639.01) DOLLARS, and, Whereas, the said makers have agreed with the holder of said mortgage to extend the time of payment thereon, NOW THEREFORE, the said <u>Jim C. And Pamela A. Olson</u> hereby agrees to pay on the 15th day of <u>July</u> A.D., 1998, the principal sum of Sixty-four thousand Six Hundred Thirty-nine and 01/00----(\$64,639.01) DOLLARS, remaining unpaid on the said note and mortgage, \$700.15 is to be paid monthly beginning 8/16/98 and each month thereafter until July 16, 2001 when the unpaid balance and accrued interest is due. with interest from July 15, 1998 at the rate of 8.00 per cent per annum payable Monthly , beginning on the 16th day of August thereafter, with both principal and interest payable at UNION STATE BANK, WINTERSET, IOWA; and the said makers hereby covenant and warrant that said mortgage is a lien on the land therein described and that it shall continue and remain as security for the payment of said principal remaining unpaid on said mortgage, and the interest as here in before stated from \_\_July 15, 1998 \_\_ until paid, and in case of failure to comply with any one of the conditions hereof, or any of the conditions of the said mortgage, all of the provisions of said mortgage becoming a part of this instrument, then the whole debt shall become due and collectible at the option of the owner of said mortgage; and all the covenants and condition of said mortgage shall remain in force except as modified by this instrument; and all sums of money not paid when due as provided in this contract shall bear interest at the rate of 18.00 per cent per annum.
