locally known as: 2644 St. Charles Rd. & 2438 Hiatt Apple Rd. together with the right of ingress and egress over the adjacent lands of the GRANTORS, their successors and assigns, for the purposes of this easement.

The Easement shall be 32 feet in width, the centerline of which shall be the water pipeline and the necessary appurtenances thereto.

GRANTEE, during initial construction and after construction is completed, and during any repair of such waterline and appurtenances, shall: 1.) Pay crop damages to Grantors; 2). Repair any fences, electric lines, water lines, and tile lines damaged by Grantee, or any persons performing such work for Grantee.

The GRANTEE, its successors and assigns, hereby promise to maintain such water pipeline and any necessary appurtenances in good repair so that damage to adjacent real estate of GRANTORS, if any damage there be, will be kept to a minimum.

The grant and other provisions of this easement shall constitute a covenant running with the land for the benefit of the GRANTEE, its successors and assigns.
