CONTRACT

THIS AGREEMENT made and entered into this 14th of July, 1998 A.D.  
By and between CHET HIATT AND GINGER HIATT

of the County of Madison, State of Iowa, party of the first part and the Madison County Board of Supervisors acting for Madison County, party of the second part.

WITNESSETH:

For good and valuable consideration, the party of the first part hereby agrees to sell and to give an easement or deed to the county for use as a Public Highway the real estate situated in the County of Madison, State of Iowa, to-wit:

In Section 33 and 34 Township 74N Range 26W Commencing at  
Station 45 + 20.51 to Station 45 + 50.00 a strip 77.91 - 120.00 feet wide Left side, from  
Station 45 + 50.00 to Station 47 + 50.00 a strip 120.00 feet wide Left side, from  
Station 47 + 50.00 to Station 48 + 00.00 a strip 120.00 - 75.00 feet wide Left side, from  
Station 48 + 00.00 to Station 49 + 61.58 a strip 75.00 - 50.00 feet wide Left side, from

Measured from center line of proposed highway as shown on plans for Project No. BROS-61(37)--8J-61.

Party of the first part agrees that the County may take immediate possession of the above described real estate and further agrees to convey same to the County for the consideration hereinafter named, on or before the 14th day of July, 1998.

The County agrees to purchase the above described real estate and take easement or deed thereto for road purposes and to pay therefor upon delivery of easement or deed, showing merchantable title.

Should the highway as finally located require none of the real estate described, this contract becomes null and void. Party of the first part agrees to pay all liens and assessments against the property including taxes payable to the date agreed. Party of the first part is hereby notified of their right of renegotiation pursuant to the provisions of Iowa Code Section 472.52

This contract will be null and void if a construction contract for the project is not entered into by Madison County by 1/1/2001.

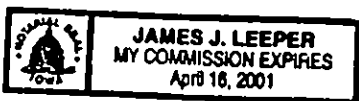
