MEMORANDUM OF SERVICING AGREEMENT

A Servicing Agreement was entered into as of August 22, 1998, hereinafter "Agreement", by and between Mercantile CHELLE UTSLAN Mortgage, the home loan division of Mercantile Bank, N.A., RECORDER hereinafter "Servicer", and Mercantile Bank Midwest, herefalled by 10 WA "Lender".

- 1. Servicer shall manage and administer the loans for the benefit of Lender.
- 2. Servicer shall perform the following specific functions in servicing the loans:
- a. Servicer shall execute and record a deed of release or satisfaction of mortgage upon clearance of the funds received by Servicer as final payments on loans.
- b. Servicer shall have full power and authority to exercise in good faith, in the name of and on behalf of Servicer and/or Lender, all rights and remedies which said parties may have with respect to the enforcement of the loans, including without limitation the rights to demand payment of any amount due, and exercise, or refrain from exercising, any and all other rights and remedies afforded under the loans.
- c. Servicer is authorized to execute, acknowledge, and deliver any instrument necessary to effectuate the intent and purposes of Agreement, including, but not limited to, deeds, releases, and any other agreements, instruments, or documents associated with normal operations.
- d. Servicer is authorized to take any and all actions it in good faith deems necessary or appropriate in connection with any loans.
- 3. Agreement was for a period of one year and will be automatically renewed unless terminated of record by the parties.
