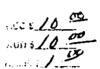

QUIT CLAIM DEED

For the consideration of \$1.00 Dollar and other valuable consideration, Pine River State Bank, a Minnesota Corporation, (Grantor) does hereby Quit Claim to J.S. Living Trust, (Grantee) all right, title, estate, claim and demand in the following described real estate in Madison County, Iowa:

The East 35 acres of the Southeast Quarter (SE½) of the Northeast Quarter (NE½); the South 8½ rods of the East 9 and 35/85 rods of the Northeast Quarter (NE½) of the Northeast Quarter (NE½); and a tract commencing at the Northeast corner of the Southeast Quarter (SE½), running thence South 57.69 rods to center of Clanton Creek, thence down the center channel of said Creek to the North line of said tract, thence East 9 rods to the place of beginning; all in Section Twentynine (29); and the West 9 rods of the South 4 rods, 7 feet and 4 inches of the Northwest Quarter (NW½) of the Northwest Quarter (NW½); the South Half (S½) of the Northwest Quarter (NW½); and the North Half (N½) of the Southwest Quarter (SW½); of Section Twenty-eight (28); all in Township Seventy-five (75) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa; excepting the right of way of Chicago, Great Western Railroad Company and excepting a tract conveyed to Madison County, Iowa, described as commencing at the Northwest corner of the Southwest Quarter (SW½) of Section 28, thence South 34 rods, thence southwesterly 26½ rods, thence East 40 rods, thence Northwesterly to a point 34 rods South of the point of beginning; except approximately 61 acres lying Southeast of the Railroad and South of Clanton Creek in the South Half of the Northwest Quarter and North Half of the Southwest Quarter of Section 28.
