- I, Dale Frank, being first duly sworn on oath, depose and state as follows:
  - 1. I am the Spouse of Esther J. Frank (the "decedent") who died on the the 18th day of October, 2009, and have an interest in the real estate described below by virtue of the fact that I am surviving joint tenant with respect to the real estate described belowThere will be no estate proceedings instituted on account of the decedent's death.
  - 2. Pursuant to Section 450.22, subsection 3 of the Iowa Code, no inheritance tax return is required to be filed in the Estate of Esther J. Frank since (i) there is no federal estate tax filing obligation, and (ii) all of the decedent's assets either were held in joint tenancy with right of survivorship solely between the decedent and individuals listed in Section 450.9 of the Iowa Code as individuals that are entirely exempt from Iowa inheritance tax, or passed by beneficiary designation or pursuant to a trust intended to pass the decedent's property at death or through any other nonprobate transfer solely to individuals listed in Section 450.9 as individuals that are entirely exempt from Iowa inheritance tax.

The following described real estate was owned by Dale Frank and Esther J. Frank as Joint Tenants with Full Rights of Survivorship and not as Tenants in Common at the time of Esther J. Frank's death:

Lot Two (2) and the West 16 feet of Lot One (1) and the East 14 feet of Lot Three (3) of Bond-Peterson Place, an Addition to the Town of Winterset, Madison County, Iowa

- 3. This Affidavit is filed pursuant to Section 450.22, subsection 4 of the Iowa Code for the purpose of establishing of record nonliability for Iowa inheritance tax without the filing of an inheritance tax clearance.
