Lender may make proof of loss if not made immediately by Mortgagor.

Unless Lender and Mortgagor othierwise, agree, in writing, insurance proceeds shall be applied to restoration or repair of the Property damaged if the restoration or repair is economically feasible and Lender's security is not lessened. If the restoration or repair is not economically feasible or Lender's security would be lessened, the lessened.
