## DESCRIPTION PARCEL- C

That part of tracts of land as described by Warranty Deed, recorded in Deed Record Book 137, Page 884, and Quit Claim Deed recorded in Deed Record Book 126, Page 376, Madison County Recorder's Office, Madison County, Iowa, and located in the Northwest Quarter and the Southwest Quarter of Section 15 and the Southeast Quarter of Section 16, all in Township 76 North Range 28 West of the Fifth Principal Meridian, Madison County, Iowa, described as follows:

The Southwest Quarter of the Northwest Quarter of said Section 15 Also described as Lots 1, 2, 3, and 4 of the Subdivision of the Southwest Quarter of the Northwest Quarter of said Section 15

Lots 1, 2, and 5 of the Subdivision of the north one half of the Southwest Quarter of said Section 15 AND

The west 3.45 acres of Lot 2 of the Subdivision of the Northeast Quarter of the Southwest Quarter of said Section 15

That part of Lots 4 and 5 of the Subdivision of the Southeast Quarter of the Northwest Quarter of said Section 15 described as follows:

Beginning at the southwest corner of said Lot 5, thence on an assumed bearing of North 89 degrees 09 minutes 42 seconds East along the south line of said Lot 5 a distance of 377 61 feet, thence North 89 degrees 09 minutes 42 seconds East along said south line 3 89 feet to the east line of the west 4 59 acres of said Lot 5, thence North 00 degrees 32 minutes 35 seconds West along said east line 524 44 feet to the south line of said Lot 4, thence South 89 degrees 10 minutes 57 seconds West along said south line 43.39 feet to the centerline of a Madison County Highway, thence North 05 degrees 45 minutes 43 seconds West along said centerline 458.50 feet to the north line of said Lot 4, thence South 88 degrees 59 minutes 37 seconds West along said north line 297.01 feet to the northwest corner of said Lot 4, thence South 00 degrees 34 minutes 51 seconds East along the west line of said Lots 4 and 5 a distance of 980 39 feet to the southwest corner of said Lot 5 and the point of beginning.

The north 32 rods of the east 10 rods of the Southeast Quarter of said Section 16 More particularly described as follows. That part of Lots 1 and 2 of the Subdivision of the Northeast Quarter of the Southeast Quarter of said Section 16 described as follows: Beginning at the northeast corner of said Lot 1, thence on an assumed bearing of South 89 degrees 33 minutes 05 seconds West along the north line of said Lot 1 a distance of 165 00 feet; thence South 00 degrees 52 minutes 29 seconds East 528 01 feet; thence North 89 degrees 33 minutes 05 seconds East 165 00 feet to the east line of said Subdivision of the Northeast Quarter of the Southeast Quarter, thence North 00 degrees 52 minutes 29 seconds West 528 01 feet to the northeast corner of said Lot 1 and the point of beginning

Said tract contains 72 065 acres and is subject to a Madison County, lowa, Highway Easement over the easterly 1 191 acres thereof
