MEMORANDUM
OF
AGREEMENT ENTERED APRIL 2, 1999

1. CONVEYANCE. JSC Properties, Inc., an Iowa corporation (hereinafter referred to as "JSC"), agrees to convey to Brad Nord that certain real estate more particularly described on Exhibit A attached hereto and by this reference incorporated herein (the "Real Estate").

2. MORTGAGE. Brad Nord and Sheila Nord agree to execute and deliver a mortgage naming JSC Properties, Inc., and James S. Cownie as mortgagees and encumbering the Real Estate to secure their performance of certain obligations under the Agreement

3. OPTION TO PURCHASE. Brad Nord grants JSC an option to purchase the Real Estate in the event Brad Nord receives at any time a bona fide offer from a third party to purchase the Real Estate, or any portion thereof.

4. RESTRICTIVE COVENANTS. Brad Nord agrees to enter and execute restrictive covenants restricting the use and development of the Real Estate.
