**APPLICATION AND AGREEMENT TO PARTICIPATE IN THE  
IOWA SCHOOLS EMPLOYEE BENEFITS ASSOCIATION**

This Agreement is entered into this 21ST day of JUNE, 1999 by and between the Iowa Schools Employee Benefits Association ("ISEBA") and the agency executing this Application and Agreement (the "Agency"), an Agency organized under the laws of the State of Iowa, and is for the purpose of providing a means by which the Agency may jointly and cooperatively proceed under the provisions of Iowa Code Chapter 28E with other Agencies to participate in the Iowa Schools Employee Benefits Association.

By participating in ISEBA, the Agency and the other Agencies participating in ISEBA, may execute powers, privileges, or authority, and make use of benefits jointly to which each of the participants separately is entitled under state and federal legislative acts.

The Agency agrees to be bound by the terms and conditions of the Governmental Cooperation Agreement establishing the Iowa Schools Employee Benefits Association (the "28E Agreement"), and such other Coverage Terms, Bylaws, rules and regulations as may from time to time be adopted by the ISEBA Board.
