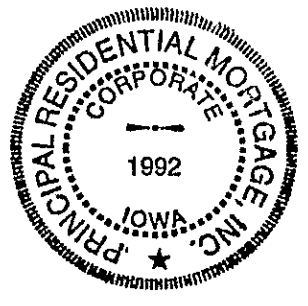
**IOWA RELEASE AND SATISFACTION OF MORTGAGE**

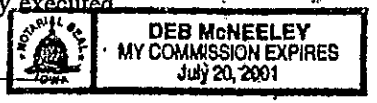
