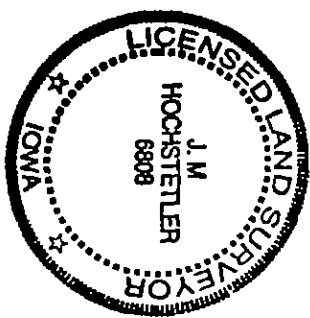
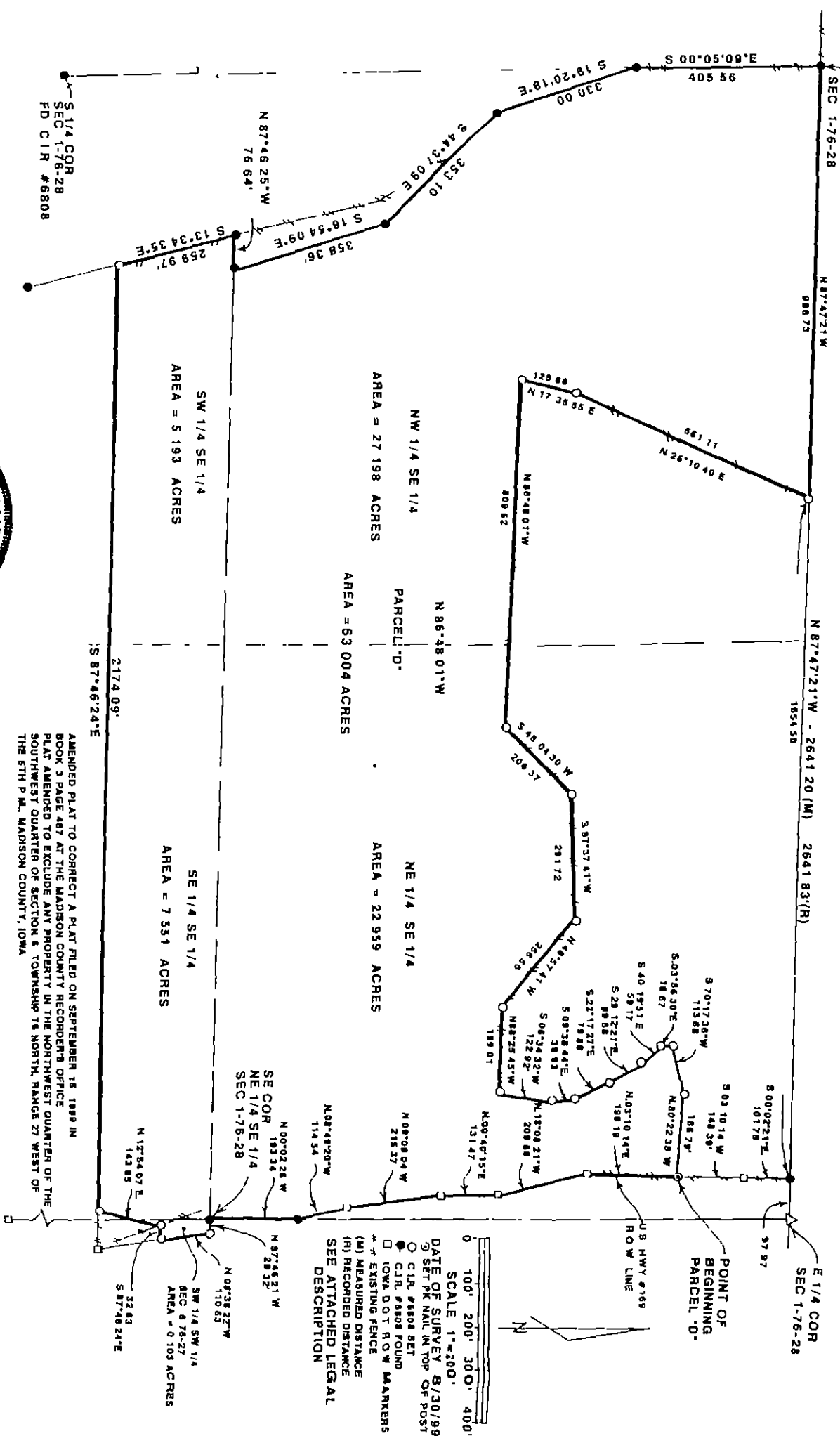

LEGAL DESCRIPTION: Parcel "D"

Parcel "D" in the Southeast Quarter of Section 1, Township 76 North, Range 28 West and the Southwest Quarter of the Southwest Quarter of Section 6, Township 76 North, Range 27 West of the 5th P.M. all in Madison County, Iowa being a part of Parcel "A" on a survey recorded on May 28, 1999 in Farm Plat Book 3 page 448 at the Madison County Recorder's Office more particularly described as follows:
