Lender may use the insurance carrier to repair or restore the Property, or Lender may use the insurance proceeds to repair or restore the Property before the acquisition shall pass to Lender to any insurance policies and proceeds resulting from damage to the Property before Lender, Mortgagee's right to any insurance payments made immediately before the acquisition.

Unless Lender and Mortgagee otherwise agree in writing, any insurance proceeds to the Payment is acquired or postponed the due date of scheduled payments and proceeds resulting from damage to the Property is acquired by Lender and Mortgagee's right to any insurance payments made immediately before the acquisition.

Unless Lender and Mortgagee otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damaged if the restoration or repair is economically feasible or Lender's security is not lessened. If the restoration or repair is not economically feasible or Lender's security would be lessened, the insurance proceeds shall be applied to repair is not economic lessened. Lender may make proof of loss if not made immediately by Mortgagee.

All insurance policies and renewals shall be accepted by Lender and shall include a standard "mortgage clause" and, where applicable, "Lender loss payable clause." Mortgagee shall immediately notify Lender of cancellation or termination of the insurance. Mortgagee shall have the right to hold the policies and renewals. If Lender requires, Mortgagee shall immediately give to Lender all receipts of paid premiums and renewals notices. Lender may receive notice to the insurance carrier and Lender, Upon loss, Mortgagee shall give immediate notice to the insurance carrier and Lender, Upon loss, made immediately by Mortgagee.

A. Mortgagee shall keep the improvements now existing or hereafter built on the Property insured against loss by fire, hazards included within the term "extended coverage" and any other hazards, including floods or flooding, for which Lender requires insurance. This insurance shall be maintained in the amounts and for the periods that Lender requires. The insurance carrier providing the insurance chosen by Mortgagee subject to Lender's approval, which shall not be unreasonable withheld. If Mortgagee fails to maintain the coverage described above, Lender may proceed to protect Lender's rights in the Property according to the terms of this Mortgage.

22. **INSURANCE.** Mortgagee agrees to maintain insurance as follows:
