EASEMENT

KNOW ALL MEN BY THESE PRESENTS

Carol J. Darnall and Douglas E. Darnall, hereinafter referred to as GRANTORS, in consideration of One Dollar and Other Valuable Consideration, hereby grant and convey unto Warren Water, Inc, hereinafter referred to as GRANTEE, its successors and assigns, a perpetual easement with the right to erect, construct, install, lay and thereafter use, operate, inspect, repair, maintain, replace and remove waterlines and appurtenances thereto, over, across and through the land of the GRANTORS situated in Madison County, Iowa, being more specifically described as follows

The Southeast Quarter (SE1/4) of the Northeast Quarter (NE1/4) and the North Half (N1/2) of the Northeast Quarter (NE1/4) of the Southeast Quarter (SE1/4), except a tract of land described as commencing at a point 655.9 feet North of the Southwest corner of said Northeast Quarter (NE1/4) of the Southeast Quarter (SE1/4), thence continuing North 208 feet, thence South 87° 40' East 417.5 feet, thence South 208 feet, thence North 87° 40' West 417.5 feet to the point of beginning and containing 1.9919 acres, of Section Seven (7), all in Township Seventy-five (75) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa

and locally known as 7284 St. Chas Rd together with the right of ingress and egress over the adjacent lands of the GRANTORS, their successors and assigns, for the purposes of this easement

The Easement shall be 32 feet in width, the centerline of which shall be the water pipeline and the necessary appurtenances thereto

It is agreed that, during the period of initial construction, no crop damage will be paid by the GRANTEE. The GRANTEE, its successors and assigns, hereby promise to maintain such water pipeline and any necessary appurtenances in good repair so that damage to adjacent real estate of GRANTORS, if any damage there be, will be kept to a minimum

The grant and other provisions of this easement shall constitute a covenant running with the land for the benefit of the GRANTEE, its successors and assigns
