ADDENDUM TO THE 28E AGREEMENT BETWEEN MADISON  
 COUNTY AND THE STATE OF IOWA REGARDING PURCHASE OF SERVICE  
 (CONTRACT RENEWAL.)

WHEREAS, there now exists a 28E Agreement between MADISON  
 County and the State of Iowa regarding the purchase of services for the mentally ill, mentally  
 retarded and developmentally disabled; and

WHEREAS, the 28E Agreement only runs for one year, commencing on July 1, 1997 and  
 terminating on June 30, 1998; and

WHEREAS, Paragraph 25 of the 28E Agreement provides that it may be renewed upon mutual  
 agreement;

NOW, THEREFORE, BE IT RESOLVED in consideration of the mutual promises, covenants  
 and conditions set forth in the original 28E Agreement which is made a part hereof by reference  
 and which is on file with the County Recorder and with the Secretary of State's Office, the  
 undersigned parties do hereby consent, through their signature hereto, to a three-year extension of  
 the 28E Agreement, which will now terminate on June 30, 2001.

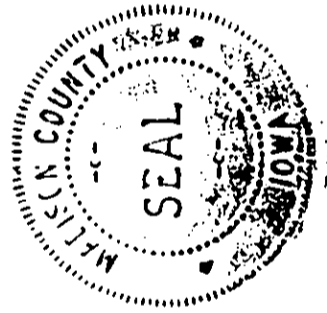
