THAT SAID PARTIES OF THE FIRST PART, in consideration of WITNESSETH: the sum of TEN (\$10.00) DOLLARS, to them paid by said party of the second part (the receipt of which is hereby acknowledged), do by these presents, Grant, Bargain and Sell, Convey and Confirm unto the said party of the second part, its heirs and assigns, all the following described lots, tracts or parcels of land lying, being and situate in the County of Madison and State of Iowa, to-wit:
