## SUBORDINATION AGREEMENT

This Subordination Agreement made as of the 25th day of November, 2009, by Union State Bank [Name of original lender], having an address of 201 West Court Avenue Winterset, Iowa 50273 ("Subordinator"), and Union state Bank [Name of new lender], a corporation organized and existing under the laws of the State of <u>Iowa</u> with its principal place of business at <u>Winterset</u>, <u>Iowa 50273</u> ("Lender").

## **RECITALS:**

- A. Michael Hochstetler and Kimberly Hochstetler [Name of Borrower], of 1471 190th Street [address], Winterset [city], Madison [County], Iowa [state] ("Borrower"), has applied to Lender for a loan to be made to Borrower and to be evidenced by a promissory note secured by a mortgage covering certain real property.
- B. The real property offered by Borrower as security to Lender is currently subject to the prior lien of the mortgage described below.
