EASEMENT

KNOW ALL PEOPLE BY THESE PRESENTS:

Raymond Parker, Jr. and Sandra K. Parker, husband and wife, hereinafter referred to as GRANTORS, in consideration of One Dollar and Other Valuable Consideration, hereby grant and convey unto Warren Water District, hereinafter referred to as GRANTEE, its successors and assigns, a perpetual easement with the right to erect, construct, install, lay and thereafter use, operate, inspect, repair, maintain, replace and remove waterlines and appurtenances thereto, over, across and through the land of the GRANTORS situated in Madison County, Iowa, being more specifically described as follows:

See Exhibit "A" attached hereto and incorporated herein by this reference.

together with the right of ingress and egress over the adjacent lands of the GRANTORS, their successors and assigns, for the purposes of this easement.

The GRANTEE agrees:

- 1. To pay for and/or repair any damage to trees, driveways, fences and tile lines caused by or resulting from the construction including the death of any oak trees caused by or resulting from the cutting of the roots of such trees.
- 2. To restore the surface of the ground to its present condition by leveling any disturbed ground in such a way so as to prevent erosion.
- 3. To replace and restore rock and gravel to the area of Grantor's driveway which is disturbed by the construction.
- 4. To remove and dispose of any trees, brush or shrubbery cut, damaged or removed by or for construction.
- 5. To pay Grantor the sum of \$275.00 per agrand for crop damage.

The GRANTEE, its successors and assigns, hereby promise to maintain such water pipeline and any necessary appurtenances in good repair so that damage to adjacent real estate of GRANTORS, if any damage there be, will be kept to a minimum.

The grant and other provisions of this easement shall constitute a covenant running with the land for the benefit of the GRANTEE, its successors and assigns.
