- 3. PURPOSE. This Mortgage and the Obligations described herein are executed and incurred for <u>Consumer</u> purposes
- 4. FUTURE ADVANCES. Upon request of Borrower, Lender, at Lender's option so long as this Mortgage secures indebtedness held by Lender, may make future advances to Borrower. Such future advances, with interest thereon, shall be secured by this Mortgage.
