

WHEREAS, the City has opened the above described real estate as a street right-of-way and has installed the street thereon; and,


WHEREAS, the City now desires to designate the name of this street right-of-way as provided by Iowa Code Chapter 354.26.

1. The street located upon the above described real estate is hereby named Mills Street.


