SW4 of the SE4 and the NE4 of the SW4, all in Section 25, Township 75 North, Range 26 West of the 5th P.M., Madison County, Iowa.

and locally known as: RR St. Charles, Iowa together with the right of ingress and egress over the adjacent lands of the GRANTORS, their successors and assigns, for the purposes of this easement.

Water line to be installed no more than 50 feet from the County Right-of-Way along the north property line. The easement shall be 32 feet in width, the centerline of which shall be the water pipeline and the necessary appurtenances thereto.

It is agreed that crop damage will be paid by the GRANTEE. The GRANTEE shall pay for all damages to tile lines caused by installation or maintenance of the water line. The GRANTEE, Its successors and assigns, hereby promise to maintain such water pipeline and any necessary appurtenances in good repair so that damage to adjacent real estate of GRANTORS, if any damage there be, will be kept to a minimum.

The grant and provisions of this easement will constitute a convenant running with the land for the benefit of the GRANTEE, its successors and assigns.
