"A RESOLUTION DESCRIBING THE BOUNDARIES OF THE FIRE DISTRICT TO BE SERVED BY THE VAN METER FIRE DEPARTMENT"

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VAN METER, IOWA:

That the boundaries of the fire district to be served by the Van Meter Fire Department shall be as follows, to-wit:


All of Sections Three (3) through Four (4); that part of Section Five north and east of the river; all of Sections Nine (9) through Seventeen (17); all of Sections Twenty (20) through Twenty-nine (29); and all of Sections Thirty-two (32) through Thirty-six (36), ALL in Township Seventy-eight (78) North, Range Twenty-seven (27) west of the 5th Principal Meridian, Van Meter Township, Dallas County, Iowa;

All of Section Nineteen (19); all that part of Section Twenty-eight (28) lying southerly of the Raccoon River; all of Sections Thirty (30) and Thirty-one (31); and all of those parts of Section Thirty-two (32) and Thirty-three (33) lying Southerly of the Raccoon River, ALL in Township Seventy-eight (78) North, Range Twenty-six (26) West of the 5th Principal Meridian, Boone Township, Dallas County, Iowa.

The West Half of Section Three (3); all of Sections Four (4), Five (5), Six (6), Seven (7), Eight (8) and Nine (9); the Northwest Quarter; the North Half of the Southwest Quarter; the Southwest Quarter of the Northeast Quarter; and the Northwest Quarter of the Southeast Quarter, all in Section Ten (10); the West One Half of the Northwest Quarter of Section Fifteen (15); the Northeast Quarter of Section Sixteen (16); the Northwest Quarter of Section Seventeen (17); all of Section Eighteen (18); all of Lot One (1), the West 41.64 acres of Lot Two (2), and all of Lot Three (3) of Section Nineteen (19); all in Township Seventy-seven (77) North, Range Twenty-six (26) West of the Fifth (5th) Principal Meridian, Madison County, Lee Township, Iowa: and

All of Section One (1) through Section Sixteen (16); and all of Section Twenty-one (21) through Section Twenty-four (24); the North Half of the Northwest Quarter of Section Twenty-eight (28); and the Northeast Quarter of the Northeast Quarter of Section Twenty-nine (29), all in Township Seventy-seven (77) North, Range Twenty-seven (27) West of the Fifth Principal Meridian, Jefferson Township, Madison County, Iowa.
