1. I am the surviving spouse of Earl E. Young, who died on the 6th day of January, 1995.

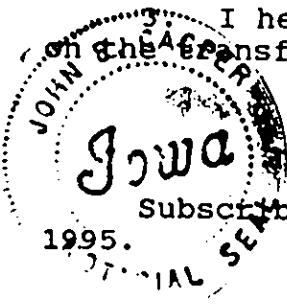
2. The following described real estate was owned only by Earl E. Young and this Affiant, as joint tenants with full rights of survivorship at the time of my spouse's death:
