thence North 84 degrees 13 minutes 53 seconds East 1303.84 feet to the east line of said Northeast Quarter of the Southeast Quarter,

thence North 00 degrees 14 minutes 54 seconds West along said east line 61256 feet to the southeast corner of the Southeast Quarter of the Northeast Quarter of said Section 13, thence South 83 degrees 57 minutes 20 seconds West along the south line of said Southeast Quarter of the Northeast Quarter a distance of 130364 feet to the southwest corner of said Southeast Quarter of the Northeast Quarter and the point of beginning
