Blocks One (1), Two (2), Eleven (11), Twelve (12), Thirteen (13), Fourteen (14), Twenty-three (23), and Twenty-four (24) of the Town of Peru, Madison County, Iowa, and the vacated streets and alleys adjacent thereto, excepting therefrom a tract of land 20 feet square out of the Southeast Corner of said Block Twenty-three (23), AND
