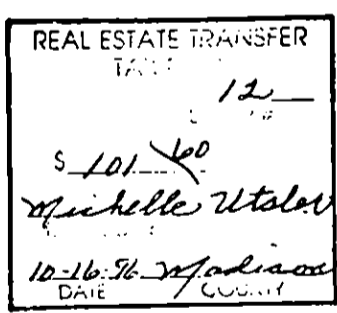
SUBJECT TO ALL COVENANTS RESTRICTIONS AND EASEMENTS OF RECORD.

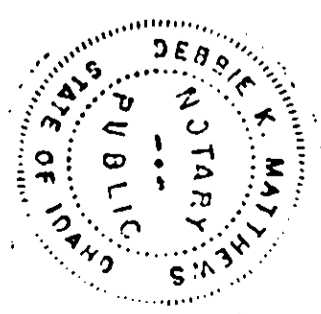
