That the parties served, as shown by said returns, included all parties in possession of said real estate at the time of service of said notice.



That, as shown by such returns, more than 30 days have passed since the service of such Notice.

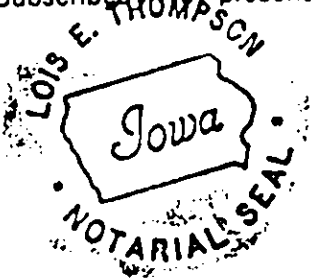
