

ATTACHMENT OF SUPPLEMENTAL COURT OFFICER DEED - LAWRENCE LAVERNE HULL ESTATE

Blocks Four (4), Five (5), Six (6), Seven (7), Eight (8) and Nine (9) and the vacated streets and alleys adjacent thereto, all in the Original Town of Peru, Madison County, Iowa, except a parcel of land described as follows: A parcel of land located in Blocks 5, 6, 7, and 8 of the Original Town of Peru, Iowa, bounded on the east by the east line of said Blocks 5 & 6; on the south by the South line of said Blocks 6 & 7; on the west by the north-south fence line through Sta. 217+40; on the northeasterly by a line beginning at a point 88 ft. normally distant northeasterly from centerline tangent on said fence line through Sta. 217+40, thence to a point 65 ft. normally distant northeasterly from Sta. 220+30, thence to a point 145 ft. normally distant northeasterly from centerline on the east line of said Blocks 5 and 6. Said parcel contains 1.25 acres, more or less.

Wherever in the chain of title to the above described property there is reference to "Lots" rather than "Blocks" Four (4), Five (5), Six (6), Seven (7), Eight (8) and Nine (9), the description is intended to, and does, refer to Blocks Four (4), Five (5), Six (6), Seven (7), Eight (8), and Nine (9). The areas and values are the same regardless of whether "lots" or "blocks" was used in the legal description.
